This warranty is offered to the original purchaser of ECOSCAPE UK Ltd CLARITY manufactured polymer-wood composite products, by Ecoscape UK Ltd. For the purposes of this warranty, the product mix consists of a range of composite deck boards (25mm x 150mm x 2900mm) with 2 surface finishes (traditional and wide grooved), balustrade components including handrails, newels, spindles, post-caps all available in five standard colours (Ash, Charcoal, Graphite, Walnut and Autumn). Any installation works accompanying bespoke installations is guaranteed for a period of 2 two years.

All Clarity composite products are guaranteed for a period of 20 years from the date of original consumer purchase under normal use and service conditions against structural damage from fungal decay, termites, rotting, splintering or splitting. If a fault does occur within the warranty period, then Ecoscape UK Ltd should be notified in writing from the purchaser. Ecoscape UK Ltd will investigate the fault and if necessary, direct a representative to inspect the deck, expenses incurred by Ecoscape UK Ltd will be charged to the purchaser at cost however will be fully refundable if Ecoscape UK Ltd's product is found to be at fault.

If Ecoscape UK Ltd composites are found to be at fault then Ecoscape UK will either replace the material or refund a percentage of the original material purchase price. Ecoscape UK Ltd will not accept any claim for any consequential losses, nor will any recompense be made to the customer for initial installation costs.

To make a claim under this warranty, the original purchaser shall send to Ecoscape UK Ltd, a description of the fault, proof of purchase and photographic evidence. Ecoscape UK Ltd is not responsible for and does not warrant against any condition attributable to (no implied warranty shall be deemed to cover):

For the purposes of this warranty, the product mix consists of a range of composite deck boards (25mm x 150mm x 2900mm) with 2 surface finishes (wood grain and wide grooved), and trim board each available in six standard colours (Argent, Flint, Havana, Industry, Silver Birch, Spiced Oak). Any installation works accompanying bespoke installations is guaranteed for a period of 2 two years.

All Forma composite products are guaranteed for a period of 25 years from the date of original consumer purchase under normal use and service conditions against structural damage from fungal decay, termites, rotting, splintering or splitting and colour consistency. If a fault does occur within the warranty period, then Ecoscape UK Ltd should be notified in writing from the purchaser. Ecoscape UK Ltd will investigate the fault and if necessary, direct a representative to inspect the deck, expenses incurred by Ecoscape UK Ltd will be charged to the purchaser at cost however will be fully refundable if Ecoscape UK Ltd's product is found to be at fault.

If Ecoscape UK Ltd composites are found to be at fault then Ecoscape UK will either replace the material or refund a percentage of the original material purchase price. Ecoscape UK Ltd will not accept any claim for any consequential losses, nor will any recompense be made to the customer for initial installation costs.
